

Notice for the first General meeting of members

Dear member,

This letter is to inform you of the upcoming first General meeting of Sunrise Funeral Co-operative members.

As you may know, a co-operative is an organization owned by a community, dedicated to providing services to said community. As a member of the co-operative, you are a co-owner of the co-operative and the General meeting of members is the event to hear about your co-operative, as well as being heard by it. During a General meeting, members also get to elect directors among themselves, to represent them on the board of directors, involved in big decisions of the Co-operative.

Incorporated last summer, Sunrise Funeral Co-operative was created with the goal of becoming the first funeral co-operative in Newfoundland and Labrador. With the help of the Funeral Cooperatives Network, its goal is to become the owner of Noel's Funeral Homes, and as such, provide quality funeral services at a fair price to communities in and around Carbonear, Harbour Grace, Western Bay and Winterton. After the incorporation, a group of 5 community leaders involved in the project from the start stayed onboard and became the interim board of directors.

At the meeting, members will be asked to vote to:

- Adopt the Co-operative's by-laws*;
- Appoint an auditor recommended by the board;
- Accept relevant decisions made by the interim board so far
 FCN membership recommendation
- Elect directors.

The meeting will be held in person only. No proxy voting is allowed, in accordance with the Co-operatives Act and the by-laws.

This is a volunteer position for a term of 1 to 3 years. You must be a regular member of the Co-operative, adopted as such during a regular meeting of the board **before** the General meeting.
